Subject: Support the Ethiopia for review and finalization of LLIN Mass Campaign Distribution Guidelines

Context: Ethiopia completed a mass campaign distribution of 5.3 million LLINs at the end of November 2017. From January to April 2018, another 6 million LLINs were distributed to 105 Woredas (Districts) in the 4 regions of Afar, Amara, Oromia, and Tigray. Further mass distribution campaigns are planned during 2019 and 2020 for distribution of 22 706 700 LLINs to populations in malarious zones of 548 woredas in 9 regions.

AMP consultant in country: Jean Marc Grégoire from July 2 to 24, 2018

Mission objectives: This support mission is a continuation of the AMP March 2018 support of a process evaluation into the roll out of the campaign LLIN distribution activities. Based on the review of the LLIN distribution strategy and the process evaluation report submitted with recommendations, the federal ministry of health is planning to update the LLIN distribution strategy guideline. The guideline will also consider gaps and reflections from a post LLIN distribution assessment conducted in June 2018. The present TA will focus on:

- Programmatic aspects;
 - Refine and update procurement and distribution plan;
 - Follow-up on LLINs delivery status and work closely with responsible entities;
 - Prepare a detailed distribution plan by Woredas indicating LLINs need and expected distribution date;
 - Guide distribution of LLINs at all levels;
 - Develop/update relevant tools for tracking and monitoring distribution and usage of LLINs;
 - Data collection, analysis and reporting mechanisms including templates/formats, supervision and monitoring aspects;
- Support the development of a LLIN 2019 campaign Plan of Action for the mass LLIN distribution campaign;
- Develop a timeline for roll out of activities and key milestones that must be met to ensure activities are started as soon as possible;
- Flag any gaps in operational planning/costs that could impact on the successful rollout of the campaign;
- Discussion and review with the National Malaria Program (NMP) and partners of existing planning and implementation tools and documents (training materials; data collection materials and management system; LLIN distribution tools; supervision, monitoring and data verification tools, etc.)


Sitrep: AMP TA to NMP Ethiopia, July 17, 2018

- The Global Fund Ethiopia country team was in Ethiopia from July 1st to 6th for consultations.
- The National Malaria Program (NMP) is participating in a Ministry of Health annual planning exercise.
- The USAID Global Health Supply Chain Program (GHSC-PSM) was undertaking a post LLIN distribution assessment of the January to April campaigns in the 4 regions of Afar, Amara, Oromia, and Tigray.

Mission roll out

To support the procurement of 10,3 milion GF sponsored nets:

• The debate on the waste management issue of procuring nets with individual plastic bags or in bulk packaging was supported by a cost analysis of transport cost to return plastic packaging waste from district level to regional centres for disposal in high temperature cement factory furnaces.



Using data gathered during the process evaluation

- that 1 bale of LLINs produces 0,0318 m3 of plasticwaste,
- according to a transport cost of x 43,96
 USD per m3 from district to region
- one bale of 50 LLINs with individual plastic bags generates a cost of 1,40 USD to return the plastic waste (0318 m3) from district to region level for disposal
- The savings of procuring LLINs packed in bundles of 50 nets without individual plastic bags for the 8 061 685



- nets of the Oromia region would be 287 168 USD.
- Ethiopia announced a pro-environment decision that the procurement of 10. 3 million LLINs would be without individual plastic bags
- The planned delivery strategy to the country was modified to take into account the estimated arrival time of the 3 different procurements, the usual rainy season by area, the malaria incidence rate and the timing of the last distribution campaign. The most important change was to have the Somali region be first in line for a LLIN mass distribution.
