Update on October 17th AMP conference call:

- AMP TA providers currently in country under CRSPC
- Sitrep shared with the minutes of this week's call
- Cameroon is planning to implement its third campaign in 2019. It is planned to distribute 14,697,104 LLINs with standard PBO and LLINs to be distributed
- Procurement through Wambo and PPM.
- 10 931 571nets will be financed by the GF and 3 765 533 LLINs will be financed by the Cameroonian government,
- When the consultants arrived, the campaign team had already drafted the first draft of the monitoring & evaluation, communication and security plans. With the GF, the PNL team had already ordered certain quantities of LLINs to arrive for the first phase of distribution.
- Preparation of validation workshops for the documents and tools of the campaign, the training of central level supervisors and logistics trainings were in preparation.
- Ongoing activities include:
- Review of campaign plan of action
- Review of campaign HH registration, distribution, monitoring and reporting tools
- Development of the agenda of the document/tools validation workshop (M&E plan, Logistics plan, Training plan, Communication plan, Household registration tools, LLIN distribution tools, Supervision tools, Reporting tools, Preparation of training of central and regional level supervisors
- Warehouses have been selected for the Eastern and Western regions and these regions do not require a tender because of the amount allocated.
- The award of the contract for the Far North and Littoral warehousing was made on 11 October 2018 after the analysis of the offers. Their contract will have to be signed in two weeks after the assessment mission of the selected warehouses.
- The contract with IDA is ready and waiting for the annexes to the contract for signature by the end of next week. However, the Global Fund has clarified that if the full payment of the required funds is not paid the manufacturer will not start production of the LLINs.
- Production of the management tools for the first shipment of LLINs will be printed by the SR at the beginning of next week.
- Training workshop for central and regional logisticians was held from 15 to 16 October in Mbalmayo. The expected participants were all present.

Update on October 17th AMP conference call:

- AMP TA in CAR supporting new PR World Vision
- Sitrep attached to the minutes of this week's call
- World Vision is in charge of planning until December 2018 the mass distribution in the 14 remaining sub-prefectures without microplanning data: Haute-Kotto (03), Basse-Kotto (05) and Mbomou (06)
- In June 2018, with the reduction of the malaria Global Fund grant envelope, only 07 sub-prefectures (Mala, Dekoa, Ndjoukou, Birao, Ouadda Djallé, Zemio and Djemah) were covered by the IFRC. The remaining 11 sub-prefectures were transferred again with the Global Fund's approval to World Vision International (WV).
- The following activities have been carried out since the arrival of the consultant in the country:
- Organization by WV of a two-day workshop for the revision of campaign materials (LOG, GAS, Finance, Communication) and the training of trainers manual
- Finalization of the materials and the training of trainers manual
- Development of the consultant's work plan and campaign coordination team work plan
- Set up of a WV-SLP coordination meeting every Monday
- Organization of a working session with WFP on the logistics management of the campaign
- Organization of a working session with PAM, SLP, WV and the 5 selected NGOs on the review, the development of micro plans and the evaluation of NGO capacities to cover the 17 sub-prefectures selected for phase 1
- Establishment of a weekly WV-SLP-NGO coordination meeting
- Development of the LLIN positioning plan in the 11 SPs with micro plans
- Development of TORs and budgets for microplanning review and development of advocacy and communication plans with local administrative authorities.
- Preliminary meeting with representatives of the CARITAS National Office to negotiate a contract for the payment of the campaign's stakeholders.
- Review and updating of the microplanning template, advocacy presentations, and the microplanning process
- Organization and monitoring of advocacy missions, review and update of microplans data in the Ndélé, Bamingui, Obo and Bambouti sub-prefectures and development of the microplans of Bangassou, Rafai, Mobaye, Kembe sub-prefectures, Satema and Zangba.

Update on October 17th AMP conference call:

- AMP TA currently in country
- Cross border planning meeting was held to review status of both plans of action as this is going to be a synchronised distribution with Senegal
- Small country with great ITN access and use
- Looking at synchronised campaign with Senegal, trying to ensure all border populations are reached
- As Gambia is seeing reductions in malaria, 2017 MIS is presenting very good results
- Transmission from Senegal who has slightly higher prevalence of malaria is part of the reason for synchronisation
- Allocation of nets does not set caps
- Standard traditional definition of a HH
- Using electronic platform but a different one from the last campaign
- Previous campaign, they were allocating an extra net to a pregnant woman and to child under 1 in HHs. Those people were duplicated in the process, so they will get rid of this to avoid over-allocation in the campaign
- Biggest risk is Senegal: they are not at same level of preparedness and have many more nets to put out
- Gambia has recommendation to do April one side of the river and May on the other side of the river. And finish in 24 days.
- Not sure Senegal can meet this timeline and get electronic data collection in place.
- Gambia completed mapping of all border villages and data available online.
- All health workers in Senegal have been on strike for last 7 months.
- Both grants have funds for cross border meetings

Update on October 17th AMP conference call:

- AMP provider has arrived in country to support process evaluation for Katsina State distribution
- Catholic Relief Services, with funding from the Global Fund, is implementing a mass campaign distribution of LLINs in Katsina State. The campaign in Katsina is being implemented by Society for Family Health (SFH).
- It is estimated that the campaign will reach a total population of 9 458 151. The LLIN need for Katsina was estimated at 5 025 650 based on household mobilisation data. To attain universal coverage 1 net for every 2 people will be issued to households' members (with rounding off for households with uneven members).
- Based on micro planning, 1,893 fixed and 153 satellite distribution points are allocated to serve the population in the 361 wards in the 34 Local Government Areas (LGAs) of the State.
- A technology-based system through a Cash and Asset Transfer (CAT) platform using Android phones is being employed to facilitate campaign process including household mobilization, distribution and monitoring, including end process surveys, to register and track beneficiaries, as well as monitor LLIN stock levels at the distribution points.
- The general objective of the AMP mission in Katsina State is to provide overall technical assistance while specifically undertaking a process evaluation for the LLIN campaign including:
 - Monitor and evaluate the use of technology in LLIN campaign
 - Review the LLIN campaign implementation strategy/model
 - Provide strategies that can be used in the Katsina campaign based on lessons learnt in Ogun and Jigawa campaigns
 - Make recommendations for improving campaign processes and outcomes
- Upon the arrival of the consultant in country, the implementation phase was at an advanced stage with many activities already completed including:
 - Microplanning
 - Identification of personnel

 - Net redemption: 42%
 - Data sync is affected by network not showing data from some distribution points on the ICT4D dashboard this was linked to internet connection related issues
 - Repetitive attempts by the recorder to sync data at the DP slows down the distribution process at the DP
 - Beneficiaries assigned to wrong DPs during HH mobilisation
 - CAT capacity to detect fraud of attempted double net redemption by some beneficiaries.

- CAT capacity to indicate peak time for net redemption (beneficiary behaviour) and inform and help the DP to plan accordingly

Update on October 17th AMP conference call:

- Cross border planning meeting was held with the Gambia to review status of both plans of action as this is going to be a synchronised distribution with the Gambia trying to ensure all border populations are reached
