Update on October 24th AMP conference call:

- AMP TA providers currently in country under CRSPC
- Sitrep shared with the minutes of this week's call
- Cameroon is planning to implement its third campaign in 2019. It is planned to distribute 14,697,104 LLINs with standard PBO and LLINs to be distributed
- Procurement through Wambo and PPM.
- 10 931 571nets will be financed by the GF and 3 765 533 LLINs will be financed by the Cameroonian government,
- When the consultants arrived, the campaign team had already drafted the first draft of the monitoring & evaluation, communication and security plans. With the GF, the PNL team had already ordered certain quantities of LLINs to arrive for the first phase of distribution.
- Preparation of validation workshops for the documents and tools of the campaign, the training of central level supervisors and logistics trainings were in preparation.
- Ongoing activities include:
 - Review of campaign plan of action
 - Review of campaign HH registration, distribution, monitoring and reporting tools
 - Development of the agenda of the document/tools validation workshop (M&E plan, Logistics plan, Training plan, Communication plan, Household registration tools, LLIN distribution tools, Supervision tools, Reporting tools, Preparation of training of central and regional level supervisors
- The procedures for signing contracts for warehousing are in the process of being finalized for the East and West regions as these regions do not require a call for tender because of the amount allocated
- The evaluation mission for the warehouses selected for the first phase has been ongoing since 22 October 2018
- Quantification update based on revised implementation plan and logistic plan

- Continuation of TA services being negotiated to the end of the year with World Vision and AMP
- World Vision is in charge of planning until December 2018 the mass distribution in the 14 remaining sub-prefectures without microplanning data: Haute-Kotto (03), Basse-Kotto (05) and Mbomou (06)
- In June 2018, with the reduction of the malaria Global Fund grant envelope, only 07 sub-prefectures (Mala, Dekoa, Ndjoukou, Birao, Ouadda Djallé, Zemio and Djemah) were covered by the IFRC. The remaining 11 sub-prefectures were transferred again with the Global Fund's approval to World Vision International (WV).

Update on October 24th AMP conference call:

- Analysis is being conducted by AMF on whether to put next generation nets in one of the provinces of DRC in Sud-Ubangi in north west side of country
- AMF is figuring out what kind of monitoring could be done

- The Global Fund is funding nets in this area of DRC
- PMI interest in doing some entomology studies on that region potentially
- AMF is planning to support LLIN distribution at the end of the 1st quarter of 2019 in a region in Equator Province with 1.6 million LLINs and during the 2nd quarter Sud Ubangi Province with 1.9 million LLINs for a total of 3.5 million LLINs followed by further regions in 2020.
- At this time AMF does not have funds to fill the entire LLIN gap but are working to cover those gaps that AMF can support.

Update on October 24th AMP conference call:

- PMI mission conducted to the southern areas to observe distribution activities
- Also doing IRS in one district
- PR is World Vision. AMP provided TA in terms of planning
- In summary, despite number of challenges, distribution is going well. The previous campaign was very delayed. Here they are only about a week off. Distribution is almost completed in southern region.
- This week, the national taskforce is meeting in Lilongwe for lessons learned to improve quality of distribution in central and norther regions.
- There are a number of concerns as there is an apparent shortfall of nets. Seems like nets from AMF are fewer than had been expected. Districts had provided for a 10 per cent buffer, and AMF has only provided a 5 per cent buffer. Having to make adjustments as they go due to this shortfall, the extent of which is not known at this stage.
- Reverse logistics and redistribution of nets will need to be sorted out
- To respond to the current shortfall, measures are being put in place: the taskforce has planned not to distribute nets in an IRS district; not to distribute in Lilongwe to some of the higher wealth quintile districts of the capital; and to cap nets per HH to make sure there are enough nets to reach their targets.
- 10.9 million nets total are provided by AMF and GF, and out of these, 2 million of the GF nets are PBOs.
- PMI looked at a realistic monitoring plan to monitor PBO nets without complicating the distribution and its schedule
- Concerns include that some nets now have to be moved around which will disrupt the PBO patterns of distribution because of the shortfall which makes the monitoring more difficult
- Overall the campaign is proceeding and on track to complete before rains start.

Update on October 24th AMP conference call:

- AMP provider has arrived in country to support process evaluation for Katsina State distribution
- Catholic Relief Services, with funding from the Global Fund, is implementing a mass campaign distribution of LLINs in Katsina State. The campaign in Katsina is being implemented by Society for Family Health (SFH).
- It is estimated that the campaign will reach a total population of 9 458 151. The LLIN need for Katsina was estimated at 5 025 650 based on household mobilisation data. To attain universal coverage 1 net for every 2 people will be issued to households' members (with rounding off for households with uneven members).
- Based on micro planning, 1,893 fixed and 153 satellite distribution points are allocated to serve the population in the 361 wards in the 34 Local Government Areas (LGAs) of the State.
- A technology-based system through a Cash and Asset Transfer (CAT) platform using Android phones is being employed to facilitate campaign process including household mobilization, distribution and monitoring, including end process surveys, to register and track beneficiaries, as well as monitor LLIN stock levels at the distribution points.
- The general objective of the AMP mission in Katsina State is to provide overall technical assistance while specifically undertaking a process evaluation for the LLIN campaign including:
- Monitor and evaluate the use of technology in LLIN campaign

- Review the LLIN campaign implementation strategy/model
- Provide strategies that can be used in the Katsina campaign based on lessons learnt in Ogun and Jigawa campaigns
- **Overall campaign planning and implementation:**
- LLINs distribution activities completed:
 - o 5 025 235 nets cards distributed
 - o 4 956 333 LLINs distributed (net cards redeemed): 98,5% net redemption
 - o 2 142 599 HH served (on average 2,3 nets per household)
- The distribution has been completed. The net redemption rate stands at 98.5%
- The highest performing LGA is Bindawa with 99,4%, and the lowest is Katsina 97,1%
- High redemption rate achieved due to good planning that incorporated lessons learned from previous campaigns (Jigawa, Ogun, Ogun) as well as high-level government support.
- All distribution data on the devices synched and exported before devices retrieval
- Stock reconciliation completed. Challenges related to the quality of Inventory Control Cards (ICCs) as most of them were poorly completed. As such, Master Trainers had to spend long time correcting ICCs to ensure consistency with information on the device, the waybill and the stock in hand.
- Reverse logistics from DPs to State level through LGAs store completed.
- Retrieval of CAT devices from the distribution team completed (one device missing)
- The end process evaluation form was reviewed to include message retention related indicators. However, inputs/corrections will not be incorporated for Katsina campaign as the ICT4D team will only be able to take them into account for the Gombe campaign.
- Training of independent monitors who will implement the end process evaluation using CAT system completed:
 - o 136 participants were trained (4 per LGA*34 LGAs).
 - o Training focused on practical exercises and included device allocation to participants.
 - o The group was divided into two classes (80 and 56). However, for such practice-oriented trainings, the classes were too big.
- 34 Civil Society Organisations (1 CSO per LGA) are conducting post distribution community sensitisation activities focusing on hang up and use oriented messages. The 2015 MIS data indicates that LLINs use in Katsina State is 53.7% (while ownership stands at 97.1%). The demand creation activities are thus designed to create a “social movement” around net hang up and use.
- Ongoing face to face interviews with partners for the process evaluation exercise: DPs/wards, LGAs teams.
- Field visits will take place next week to monitor the post distribution comm activities as well as end process evaluation (October 22nd-23rd)

Update on October 24th AMP conference call:

- Upcoming AMP mission to work with the PNLN on their cross border campaign with The Gambia
- For Senegal, they have the cross-border part and then they have another 9.7 million nets to get out for the rest of the country. So, they cannot get too distracted with the cross-border (which is probably about 300,000 nets or so).
- In addition, they have elections in February with a second round likely in March - April and a national health workers strike ongoing for the past 6 months (which they expect will be over once the elections are done).
- AMP has had meetings with both Gambia and Senegal : these campaign approaches are quite different and so there's quite a way to go for a harmonized distribution in Q1 / Q2 next year.
- The Gambia has conducted the mapping for all villages within 2km of the Senegal border
- AMP mission is likely to begin the week of the 19th (following the Senegal team's return from the training in Nairobi) and AMP will probably need to travel to The Gambia for the cross-border meeting

with the GF and the NMCPs the 26th - 28th of November before returning to Senegal to complete the mission.
