Updates provided during the call: **Sudan**

### **Sudan**

- GF approved the budget, country is working on finalizing the agreement, it will take additional 3-4 weeks, the team is facing unavailability of funds.
- Sudan recently suffered floods in addition of having other competing priorities in the country. Support teams in country are overstretched and deployed to assist in other emergencies. We are lacking support for our campaign.
- 6 shipments were transported from port to state level facilities
- Team is working on advocacy for campaign., but the situation is critical.
- A call with GF, RBM, AMP, UNICEF and NMCPs will be organized to discuss the situation and find solutions to problems
