## **Country Updates**

Updates provided during the call: DRC, Haiti, Liberia, Mauritania, Mozambique, Pakistan

#### DRC

• Team is concentrating on next steps in campaign digitalization efforts in country. An open source software has been updated and will be used for 2020 campaign. Previously exiting platform has been customized.

#### Haiti

- Country is working on IOM proposals.
- Team is trying to resolve issues around available tablets. There are 200 tablets available and it was decided to use the tablets in 1 district only, keeping paper-based methods in remaining districts. Teams are in discussions to find best possible approach.
- On SBC related work, Miko has shared with teams on the group options and proposals for radio scripts, posters, messaging, and other communication materials. Hopefully the SBC activities will take off and there will be no delays.

#### Liberia

• TA providers and country teams had a call on future campaign.

- Possible strategies of campaign adaptations to COVID-19 pandemic context have been presented to the country representatives. AMP also shared recommendations. Follow up meeting is scheduled for Friday to decide on strategy for upcoming campaign.
- Final decision on adaptation strategy will allow teams to move ahead with costing and budgeting work.

#### Mauritania

- Micro plans have been finalized.
- Teams considering distribution of left-over nets from 2017 campaign. The nets have been stored for 3 years in warehouse facility, the durability of the nets for the period has been confirmed.
- NMCP prefers to spread left-over nets distribution across all districts. Team is working with NMCP to evaluate if this approach is the best possible option.
- Team has finalized delivery schedule overview and adopted revised timelines
- Timeline of distribution has been revised; delays that have been discussed in previous AMP Conference calls led to postponement of distribution to September 29<sup>th</sup>, 2020.
- In addition, the nets will be sent to health facilities, nets will need to be stored in health facilities 19-30 days before distribution
- Team is revising the budget and plans
- Training will be organized on logistics, supply -chain and traceability between 11 and 15 September at all levels

#### Mozambique

• Due to late arrival of nets the team decided to do distribution only in 1 province. Initially campaign was planned in 2 provinces

#### Pakistan

- Plan of actions has been updated
- Delays are due to prepositioning of nets, these issues subsequently delayed other activities. Prepositioning of nets at distribution points has been challenging issue due to security problems in certain areas and nets being high-level commodity in country.
- Microplanning workshops concluded, teams will address the issues raised during the meetings, especially questions around participation of military in certain districts for safety reasons.
