Situation globale de la planification et mise en œuvre de la campagne :

Les activités réalisées dans la semaine du **03 au 09 février 2020** ont porté sur :

- Séances de travail avec différents acteurs de la campagne (SLP, DGS, DAF, SENLES, PNUD) ;
- Révision de texte mettant en place le comité de coordination de la campagne
- Elaboration du canevas de micro plan du niveau formation sanitaire et niveau des Moughataa
- Elaboration des canevas de MPT & MPP niveau de Moughataa
- Revue des outils de gestion logistique de la campagne
- Revue des supports de formation Logistique
- Elaboration draft consolidé du Plan de mise en œuvre de la campagne 2020
- Elaboration du Plan de communication consolidé de la campagne 2020
- Revue des outils de dénombrement (Coupon, registre, fiches synthèses et fiches supervision.)
- Mis à jour du chronogramme de la campagne, proposé avec les grandes prochaines étapes.

Défis majeurs

- **Non-respect du calendrier de la campagne** : absence de plan d'action validé, retard de mise en place du comité de coordination de la campagne (CCC) pour valider les stratégies, absence des données de micro plan, pas de définition claire des rôles et responsabilités des acteurs, pas de signature de contrat entre le BP/SENLS et le SR/SLP, non réalisation des activités prévues en décembre 2019 et janvier 2020. Toutes ces conditions préalables ont amené à la modification du chronogramme avec un décalage de la distribution jusqu'à mi-août 2020.
- **Coordination de la campagne MILDA dans la zone de OMVS** : absence de communication entre OMVS et le SLP, besoins d'harmoniser les stratégies et les outils de la campagne dans les 2 zones, besoins de fixer de manière consensuelle là ou les dates de distribution de MILDA : Nécessité de l'OMVS d'intégrer la coordination mise en place par le Ministère de la santé. Car il a été décidé que la coordination, les stratégies et les outils de la campagne doivent être uniques et alignés.

- **Démotivation du personnel de SLP** : insuffisance de bureau pour le staff du SLP, retard enregistré dans la nomination officielle du personnel du SLP et poursuite des travaux de réhabilitation dans le nouveau bâtiment où est logé le SLP sont autant de facteurs qui amènent le personnel de SLP à être irréguliers ou absents au lieu de travail. Cette situation compromet directement la mission des Assistants techniques de l'AMP qui risquent de ne pas atteindre les objectifs de la mission.
