- For SBCC activities went well. Found that the districts were reporting on a weekly basis. Not sufficiently detailed. Trying to figure out where the weakness is. Looking at what is happening in May of next year.
- Previously, they were not going to have a lot of products for the SBCC campaigns. Looking at ensuring there is limited/ no rumors for multi-product distribution on one net being better than any other.
- Has number of HHR challenges, going to move to no capping.
- Focus of the mission has three tasks. Trying to ensure that all HHR are registered. New ITN reconciliation process, and 3) micro-transportation tools that they have used previously.
- Need to figure out how they are going to distribute the right type of net during routine distribution following campaign.
- Challenges to Nampula distribution- really going to struggle to fill gaps to the right net
- Country has recently conducted a planning meeting with Nampula and Cabo Delgato provinces.
- Tool from the NNP group shared with the team: country is reviewing this from a country perspective
- Issues to be addressed before next year's campaign
- Earliest microplanning will take place is December after the elections


### **Timing**
