Ongoing Issues:

Update on January 22nd AMP conference call:

- Eight Total People on Mission- Two people from NMEP and two SFH Nigeria/ and 4 AMP TA providers
 Lots to coordinate with this group.
- Have Nigeria team in country to observe the microplanning exercise that Nigeria countries to struggle with.
- The Nigeria team participated in the ToT and participated in the workshops.
- Lots of challenges developing the micro-transport plans based on the layout of both Freetown and the rural areas of the country.
 - Far more detailed planning then what is needed from other countries.
- A lot of moving parts to decide upon; need to give more flexibility to the district tools.

- We will see if GF allows for that level of flexibility.
- To complicate the distribution SL is planning on having and integrated campaign
- Unicef does not have funds for the VitA and mabendazole so still TBD if the integrated campaign will happen as envisioned
- Need to now use GF grant to adapt the SBC campaign and training for other other child health areas. That puts pressure on the timeline and cost designated for ITN distribution.
- Nigeria team has already adapted tools for their own microplanning from what they have experienced in SL.
- Q. How has Nigeria participated in the training?
 - Well, they have had to make decision about what area they want to focus on and have choosen to support district level planning which they have used to redevelop their own tools.

- Previous Notes (Jan 15th)
- AMP TA objective to provide support for the planning and implementation of the microplanning exercise (including planning, organisation, and development of tools, ToT, and monitoring of district microplanning workshops). Finalise ITN campaign data tools/templates (including logistics and SBCC) and review campaign documents (timeline, risk mitigation framework, campaign budget).
- Working sessions with command center to finalize microplanning training agenda (TOT and microplanning workshop), presentations and review of documents (risk mitigation framework, timeline, microplanning templates, campaign data tools, etc.). Logistics training took place during the first week of the mission. **Challenges**:
- The campaign budget was developed as a stand-alone campaign but later it was agreed that the campaign will be integrated with MCH and no additional funding is provided for the MCH component
- Increased workload for the campaign personnel but there is no increase in their number to complement the integration
- New country clearance and waiver procedures has delayed the customs clearance process for the first lot of containers that arrived in country which led to unexpected demurrage costs
- Insufficient details on the progress so far by IHPAU on the preparations for the campaign (e.g. engagement venues at district and PHU levels, identification of transport companies, etc.)
- Incorrect quantification of materials
- IHPAU needs to interact more with the logistics team to have a better understanding of potential transportation challenges in WAU and WAR that will arise during micro logistics
- It has been decided that gloves and masks will be used by personnel and DPs this raises SBCC concerns in regard to the message that this will give to communities concerning the safety of using ITNs.
- SBCC tools and activities have not yet been finalised. This raises concerns (about quality and implementation), given the short timelines now available before HHR and distribution.
- Many activities are planned in a short period for the campaign and broader NMCP activities (e.g. MPR)

- The CMA audit is going on today.
- Sudan has come forward to adopt AMP which I think will be interesting and good from both the country and AMP.
- One of the challenges is that malaria control is across multiple functions. Need to have to address this going forward.
- They are sending a large representation to the AMP presentation.

Previous Notes (January 15th)

- The Commodity Management Assessment (CMA) is meant to assess the robustness of the supply chain and management of LLINs and provide recommendations on areas of the supply chain that needs to be strengthened for future LLIN activities (campaign or continuous distribution).
- The key objectives of the exercise are targeted to focus on both mass campaign and routine distribution systems to assess;
- The internal transport, storage and handling of LLINs at the various levels of the supply chain and warehousing practices and recommend how the LLIN supply chain could be strengthened within the planned Integrated Supply Chain System of Sudan.
- To explore the feasibility of using shippers own Container (SOC) in the context of Sudan
- State level engagements with key counterparts to communicate mission objectives and the sampled aeas for the assessment were conducted in North Kordofan, Blue Nile, Gadarif and Kassala.
- Data collection exercises were conducted at the following levels
 - State level commodity and warehouse assessments in North Kordofan and Gadarif states
 - Locality level commodity and warehouse assessments in 2 Localities each of North Kordofan and Gadarif states
 - Village distribution points/health facilities (6 DPs and 2 routine LLIN distribution HFs) assessments
