General updates:

The use of mosquito nets in artisanal fisheries: A global to local perspective

- Presentation by Rebecca Short (<u>Rebecca.Short@zsl.org</u>)
- Powerpoint attached to the minutes of this week's call
- A PHD research on alternative use of nets as fishing gear. Issue was identified as a serious barrier to going to scale
- Setting the scene on a global level through a global questionnaire to get to grips with the scale of the issue aimed at government officials and NGO workers working in malaria field
- Issue is happening pretty much everywhere where there is water.
- Looking at how the issue has grown over time mirrors increased access to nets.
- Through observations and focus groups it emerges that there is a trade-off between use of nets over beds and fishing.
- Gender divide in ways fishing occurs: women fish in shallow waters, men go off shore for large captures of large fish which is the more worrying trend. These catches are the most concerning.
- Damaging aspects: use in fragile habitats and fishing grounds can have effects on water and fish conservation
- How the issue impacts anti-malarial efforts: trade-offs between feeding families and protecting people from malaria. Ensuring that people are not more susceptible to malaria because they are hungry needs to be kept in mind
- Evidence that there may be positive benefits: opening up availability to women for fishing opportunities. Some people have become reliant on the activity.
- Next step should be to get representatives from across public health and conservation to look at this
 issue and look at novel interventions at a policy level to advise people in operational teams to tackle
 mosquito net fishing.
- Workshop planned 31st October 1st November of this year in the UK with the aim of getting recommendations for a policy paper. Goal is to achieve commitment from all sectors to commit to this issue.

Container delivery and storage - Organizing a time for a call

- AMP's country support working group is organizing a call to discuss the issues around container delivery and storage.
- The call will take place on August 2 at 9AM EST for the hour before the AMP call on the AMP conference call line. A call reminder will be sent closer to the date of the call.
- Issues that will be covered would include some "technical" considerations (e.g. how long can nets be stored at what temperatures, what is needed to protect the nets if they will be stored over long periods,

etc.) and some issues will be of a more "operational" nature (e.g. machines for offloading containers, reception of nets, restocking into the containers and estimated need for extra storage space, etc.)

Update on July 26th AMP conference call:

- PMI is conducting monitoring in Alibori and Bourgou
- Teams are functioning per protocol and there is synchronization of activities in the two departments.
 Last Monday and Tuesday all local supervisors were trained followed by training on Wednesday and
- Thursday of the registers. Briefings were also held with local authorities and town criers last week.
- Teams received materials Thursday and Friday with the exception of the vests that are supposed to make teams more easily visible. This gap was noted in day one and the NMCP is working on resolution. Including recommending the use of polio campaign vests.
- One evolving challenge is the registration of too many very small households in some teams up to 50% of coupons went to HHS with 4 or less people yet projections made on HH size based on 8-10 people.
- In these areas, some teams exhausted registration book on days 2 and 3.
- A small buffer stock of registers was provided to teams so they can continue for now.
- The National supervisors on the ground have provided oral guidance on avoiding over segmentation of HHs per compound that appears to be working.
- One big problem is the weather. There have been intermittent downpours sometimes lasting hours. This
 doesn't appear to have slowed down teams but some communities have become inaccessible due to
 flooding and broken bridges. Apparently rains get even worse in August in the northeastern
 departments.

- Guinea-Bissau implemented a Universal Coverage LLIN distribution campaign planned for an estimated population of 1 821 040. In compliance with the three-year replacement cycle to maintain universal coverage the 2017 campaign is a follow up to the 2014 LLIN universal distribution campaign
- Distribution took place from 21st May to 4th June
- All activities were implemented as planned
- A presentation of results will be shared soon to the AMP partnership
- Campaign planning began with support of AMP in late January/early February. Follow up support from AMP for logistics and implementation also went a long way to manage the process of campaign planning
- Most challenges that were met kept repeating themselves such as lack of technical support and struggle with capacity and human resources.

Because we could not use mobile money, this led us to have rent over 12 vehicles over 2 months which placed heavy burden on the budget. Had to continuously make revisions to the budget on a weekly basis which was also a challenge.
- Challenges in positioning of nets from health centers to distribution points, there were a lot of transportation challenges that delayed nets reaching distribution points at the time of the campaign. Needed to do a mop up at end of campaign to make up for this.
- Monitoring of HH registration was done by an independent research center
- Over 2 million people reached.
- Planning to do post campaign impact survey with access and use results. Should be able to compile these results with campaigns in 2011 and 2014. Results should be available by end of first trimester of 2018.

 - Verify the proper filing and quality of supply chain tracking tools. Document the extent to which reports are complete and reliable (supported by corresponding waybills, stock sheets, inventory control cards and tally sheets).
- AMP was requested to provide TA for the development of a CMA package and training of a local firm to conduct the CMA field work and produce a report outlining detailed findings, including recommendations for improvement of the logistics systems if/where needed.
- Continued meetings last week with entities involved in the SNP4 supply chain to finalize the gathering of all information and data required for the development of the CMA tools, SoPs and CMA report format.
- Meeting last Friday with the representatives of the firm contracted to carry out the CMA in order to review all the data and information obtained thus far and to introduce the basic principles on which the CMA data collection tools will be developed
- Development of the CMA data collection tools and drafting of the CMA SoPs over the course of last weekend. Development of the tools posed some particular challenges as the SNP4 supply chain structure and management tools differ in many aspects from normal/standard setup and procedures.

Ongoing issues:

- Need to follow up with the country after communication mission last year to see how far they have come with recommendations and plan next phase of support
- Swaziland is currently working towards elimination
- NMCP and AMP TA provider have reviewed previous communication strategic plans aimed at the community at large.
- NMCP and AMP TA provider are reviewing the acceptance of interventions
- Will work on outreach via health workers in rural health areas. Will focus on population travelling through Swaziland mainly from Mozambique
- Are looking at a plan to have malaria prevention meeting with both traders that travel to boarder countries and Mozambique population in Swaziland
- Working to enhance communication activities in high burden areas via the creation of malaria elimination committee meetings
- Looking at targeting the transport industry with IEC materials for lorry drivers.
- Messaging to travellers to take precautions when they travel to Mozambique
- Will pass messages on malaria prevention in schools, churches, mosques.
- The programme is working on the concept note for the NFM to be submitted by June 15th the concept note is now close to final, but they are still revising the health promotion section.

- They have just finished data collection in the field for the KAP survey which they are conducting

- Just from being in the field even though analysis has not been done yet, the team have clearly observed that nets are not being used. There is low risk perception because of the low malaria disease burden in the country
- In their NSP, nets have not been included and the Global Fund (whose team is currently in-country) agree that they should not be
- However, there are nets that were procured last year which had not yet been distributed. The plan with those was to replace/replenish the old nets. Now Global Fund has given the Programme the go-ahead to distribute them
- The exercise may commence beginning of the malaria season round September or so
- These will probably be the last batch of nets
- The strategy will then be to focus on IRS, environmental management etc.
- The plan is still to promote usage as there are nets currently awaiting distribution.
