# Ongoing issues:

- Household registration gave a population of 27 031 965 inhabitants for a number of LLINs of 14 815 826
- There is a gap of 2 641 783 LLINs.
- During the CNO meeting of the campaign on May 24 a withdrawal scenario was proposed taking into
  account the LLINs available exclusively for the campaign. This scenario projected a withdrawal from
  households to receive three (03) LLINs, which represents the average size of households from the
  macro and micro-planning data
- They want to cap at 3 (no households will get less than 3) everywhere and have submitted this proposal to the Global Fund for approval
- This new scenario gives a gap of 611,190 LLINs, broken down as follows: 429,430 Ordinary; 133,440 PBO and 48,320 IG2.
- The new 611 190 LLIN gap is almost similar to that of micro-planning and could be filled by:
- Routine stock returns from areas where districts will no longer use regular LLINs for routine.
- Routine stock for PBO and IG2 nets acquired for the years 2019 and 2020 that will be available before the start of the campaign.

# **Update on June 5th AMP conference call:**

- The campaign chronogram has undergone extensive revisions.
- Minister of Health has called a high-level meeting on Friday June 7<sup>th</sup> with all partners to discuss the status of the current LLIN distribution campaign
- Far North, current chronogram planning
  - Data training: 7-8 June
  - Training of health area supervisors: 8-10 July
  - HH registration: 11-21 July
- AMP TA provider (Yves) is joining VectorLink weekly calls and we are coordinating on key planning elements
- VectorLink is now sharing a weekly update with NMCP, PMI and partners in Cameroon for the Far North campaign.

#### Ongoing issues:

- AMP mission ongoing sitrep attached to the minutes of this week's call
- Cameroon is planning to implement its third campaign in 2019. It is planned to distribute 14,697,104
   LLINs with standard PBO and LLINs to be distributed. 10 931 571 Mosquito nets will be financed by the GF and 3 765 533 LLINs will be financed by the Cameroonian government.
- After a halt of the campaign due to the selection of the transporters, the work was relaunched by the negotiations with WFP. WFP has been able to interact with the PNLP and beyond it has been able to develop a transport plan, a budget and a timetable.
- Phase II-Adamaoua Region and Northern Region:
- Counting of households and distribution of outstanding coupons
- Supervision of household registration activities
- Communication activities through community radios and through national channels
- Collection and daily capture of data through the DHIS2
- Share data by area, district, and region to all supervisors at each level by WhatsApp daily.
- Payment of the actors for the training activities after submission of training reports and supporting documents
- WFP working for 2nd phase LLIN transport bid
- Phase I: Littoral (1st phase), South, East and West
- Meeting between WFP and regional teams
- Meeting between WFP and the various selected carriers
- Beginning of transport of LLINs to the region.

- AMP mission ongoing weekly sitrep attached to the minutes of this week's call
- TA for 2019 targeting regions 1, 2 and 3 in 2 phases
- With support from AMP consultant, developed macro plan with the budget, and chronogram of all activities for 2019 finalised
- Planned that camping covers 39 sub prefectures, but based on last 2-year campaigns, realised that it will be hard to cover all districts. Idea is now to cover only 22 districts out of 39 and see if we can cover the rest next year
- Continuation and finalization of the review of the micro-planning framework.
- Joint review with the SLP team of communication materials to be used during advocacy activities (presentation, strategies, key messages, list of information to be collected)
- Development of a checklist to support advocacy meetings
- Development of messages for the convocation in Bangui of the participants of the training of trainers workshops to facilitate the micro plans of the sub-prefectures
- Preparation of presentations for the training of trainer's workshop to facilitate micro-plans of subprefectures (agenda, campaign strategy, roles and responsibilities of actors, overview on the microplan, conduct advocacy meeting)

- Call took place on May 24th with AMP to finalise the 2020 campaign budget with the country
- Number of procured coupons in the budget have increased: it had been noted during the 2017 mass campaign that there were insufficient quantities of vouchers, probably in connection with the fact that they were distributed in polygamous households hence the 30% increase in the budget to reflect this fact. Since this increases the budget by nearly 18 million FCFA, they will discuss today an alternative strategy to address this problem.
- Distribution sites to cover 600 households regardless of the environment (urban or rural). However, we must take into account exceptions related to the distance from a village to a main site or for specific sites (nomads, refugees, etc)
- Government has already transferred CFA 1,500,000,000 to support UNDP for the purchase of LLINs for the regions of N'Djamena and Barh El Gazal. The balance will be paid before December to supplement the purchase costs of LLINs and the operating costs.
- As a result, it can be ensured that the mass campaign will be taking place in 13 regions instead of the 11 included in the plan.
- First distribution planned for February next AMP mission towards end of this year
- AMP is working at a distance to finalise its comments on the plan of action, communications and logistics plans.

- The mass distribution of LLINs is scheduled for July 2019.
- Mission objectives: support the planning of the LLIN mass distribution campaign in three parts: train the trainers in campaign logistics and update the transport plan based on the final microplans; finalize and validate the district microplans; and prepare the training of trainers for household registration and distribution.
- The timetable for the campaign provides for the distribution of LLINs to beneficiaries in July 2019. All LLINs for the campaign have been received and centrally stored. However, there are delays in implementing some critical activities. For example, the planned micro-planning meetings to be carried out in January are in progress and will probably end in May 4, i.e. 04 months late.
- Preparation with the CRS team of the training of trainers workshop in management and logistics
- Review and finalization of the ToR and agenda of the workshop
- Review, update of the different presentations and distribution of tasks between the facilitators of the workshop
- Facilitation of the 3-day training workshop for trainers at central and departmental level in LLIN management and logistic follow-up

#### **Update on June 5th AMP conference call:**

- AMF supported New Net Project will evaluate the effectiveness of next generate nets. The objective is to roll out a less expensive evaluation methodology.
- Evaluation methodology has been developed in collaboration with PMI, GF, Liverpool School, AMF, MoH
- Overall evaluation costs will be significantly less expensive than traditional evaluations.
- Distribution of next generate LLINs will start in Sept 2019.
- Will test prevalence of malaria at health facility level in advance of LLIN distribution and then test malaria prevalence post distribution.
- Will compare malaria prevalence in areas that received next generation LLINs to areas that received traditional LLINs.

- Next in-country mission in June for the post campaign lessons learned workshop and develop recommendations for 2021 campaign. ToRs have been developed
- One of the things we will work on is ensuring that the sessions on the agenda are as forward looking as possible to avoid a lot of time spent rehashing the problems.
- The objective should be to come to clear and concrete recommendations to reinforce what went well, plan for expanding on some of the innovations (or introducing new ones) and ensure that we address the challenges that have come up.
- For 2021 all activities should be planned in advance and budgeted versus a reactive process of addressing issues as they come up
- For the continuous distribution there was an issue on pregnant women in principle, they should not just receive a net through the community channel as it means that they may not attend ANC for the full package of services (which in turn has a negative effect on indicators related to ANC visits and IPT, among other things). So, how will pregnant women (or children that would get a routine net for completing vaccination) be managed? Would they go to the facility and then once they have an ANC card, they could receive their net through the community channel? Need to have some more discussions on the CD planning during the AMP mission next month
