General updates:

Discussion on Tana net situation (feedback from Lilia Gerberg, Health Science Specialist - PMI):

Lilia provided a brief update on the Tana situation from PMI's perspective: PMI has been exchanging information with Tana around the production issues they reported, impact on the nets produced, and evidence that the corrective actions they put in place addressed the concerns. We are working to secure additional information from the manufacturer to help inform decision-making.

We are in ongoing conversations with PMI focus countries, providing field teams with information from the manufacturer and our analysis about potential impact on timing of mass campaigns. They are in discussions with the NMCPs in their respective countries, so the NMCP can weigh available information and determine how they would like to proceed. By undertaking due diligence, we feel countries have the information they need to make informed decisions around the Tana nets, weighing the delays in replacement with country specific needs to protect people with, at a minimum, a physical barrier.

The Global Fund has posted a Q&A notice on its website to provide recommendations and advice on the basis of information that was transmitted by the manufacturer H. Sheikh Noor-ud-Din & Sons (HSNDS) regarding the Quality issues of DawaPlus 2.0 commercialized by Tana

The PMI focus countries where nets are currently being held or in shipment/at the factory are: DRC, Guinea, Kenya, Mozambique, Niger, Nigeria, and Uganda. Tana nets have already been distributed in some other countries (prior to PMI's awareness of this issue); nets are being monitored in Ghana and Madagascar via durability monitoring activities that had already been planned / underway in those countries.

- AMP mission ongoing sitrep attached to the minutes of this week's call
- Burundi is planning distribution in 2020 of 6,978,428 nets to 12 million people (including 12% allowed buffer)
- UNDP is the GF PR in charge of managing the grant,
- NMCP (SR) is in charge of overall campaign implementation, and Caritas (SR) is in charge of training and implementation at community level,
- UNDP is about to confirm with the UNICEF procurement unit in Copenhagen a purchase of 6,531,828 nets financed by the GF. Of these 553,266 are PBO nets,
- PEPFAR will provide 446,600 nets for the campaign.
- TA's TOR is to assist NMCP and partners in macro planning the 2020 campaign.
- Continuation of macro plan workshop (March 19-22) involving NMCP, UNDP, Caritas and partners continued for the remainder of last week and started today to last until Friday March 22. The workshop participants discussed SWOT, lessons learned from 2017 distribution campaign.
- The following documents in process of being prepared are advanced in draft form:
 - o Risk analysis and mitigations,
 - Timeline
 - POA is being discussed and draft in process including M&E and Comm plans.
 - o Draft LPOA is in process of being prepared
- The Delivery strategy to Burundi is to be directly to 3 regional warehouses in (Ngozi, Gitega et Bujumbura)
- The next step will be pre-positioning to 119 Commune level warehouses 3 weeks before distribution.
- The final positioning is planned to an estimated 1745 distribution points from the Commune level storage in the 10 days before distribution to the population
- UNDP has proposed that WFP be chosen to manage the supply chain from arrival point in Burundi to the distribution points.

Ongoing issues:

- Guinea's last mass distribution campaign was in 2016. To sustain the gains achieved in the past, the
 Ministry of Health will implement nationwide in 2019 a mass LLIN replacement campaign to distribute
 LLINs in 8 regions, covering all of the country's 38 districts for an estimated population of 13 236 234
 based on a projection from the 2014 census (using a 2,3% annual increase).
- LLIN quantification was established dividing the population by 1,8 to provide 1 net for every 2 people (allows rounding up for households with uneven population) and adding 20 % as a buffer stock.
- Guinea needs to procure 8,825,000 LLINs for the 2019 campaign.
- Different partners are supporting LLIN supply for the campaign as follows:
- Against Malaria Foundation 4,500,000 LLINs (1,000,000 to be confirmed for Phase 2),
- Global Fund 1,884,500 LLINs,
- PMI 871,218 LLINs,
- OMVS 600,000 LLINs, (Organisation for development of the Senegal river basin)
- and the Guinea government would supply the 837,000 LLIN gap for Conakry
- It was decided to diminish plastic waste by choosing to have nets without individual bags thus nets in bulk packaging conditioned in bales of 50 LLINs will be procured. They are scheduled for delivery in country in time for the distribution in 3 phases.
- Mission Objectives:
 - Provide technical advice related to mass campaign implementation to the Guinea national malaria control programme (NMCP) and partners with a particular focus on household registration, coupon allocation to beneficiaries and monitoring according to the campaign plan of action.
 - Identify obstacles and bottlenecks which could affect household registration and propose solutions to assure a smooth operation and validation of results
- Catholic Relief Services (CRS) as the Global Fund principal recipient (PR) and RTI-Stop Palu for PMI are implementing partners in support of the Guinea NMCP for the 2019 LLIN distribution campaign.

Update on March 20th AMP conference call:

- The Mozambique NMCP and World Vision (PR) are working towards a mass ITN distribution campaign covering all parts of the country except Maputo Province and Maputo Cidade in 2019 / 2020. Based on the quantification for procurement, approximately 14M nets will be distributed in the country.
- The ITNs to be procured and distributed include standard LLINs, PBOs and IG2. For the IG2, the quantity available is insufficient to cover an entire province, so the targeted province will receive standard and IG2 nets in 50% of districts each.
- Mozambique will hold national elections in the third quarter of 2019, which is a factor in the provincial campaign roll out.
- Two provinces are targeted for campaigns in 2019: Nampula and Cabo Delgado, planned for a total of approximately 5,346,710 nets to 9,623,999 persons. However, there are concerns regarding the security situation in Cabo Delgado which may create challenges for implementation of the campaign as per the planning to be determined by the MOH / NMCP. The distribution in Nampula is scheduled for May June 2019.
- Following the Nampula distribution, the country will roll out distribution in waves in 2020 for the remaining targeted provinces.
- It will be a G2 country 1 province will be designated for receipt of G2 nets and study will take place.
- ToT scheduled to take place this week, but not sure if there are delays now with the flooding
- No routine nets available in the country right now
- Might need to activate the emergency fund to help provinces that are most affected
- PMI is assisting with moving nets left over from campaign to southern districts affected by flooding.

- Sudan is planning a universal distribution to begin in 2019 in 12 states. Vector control strategies are multi-prong:
- The implementation of larval source management in urban settings
- The universal distribution of LLIN in 12 target states
- The deployment of IRS in the states of Gezira and Sennar
- The reported low use of LLINs in households was addressed in a SBCC "advocacy" campaign in late 2017 and early 2018. UNICEF carried out this campaign which consisted of household visits by a health promoter.
- In addition to campaign related communication activities, the Federal Ministry of Health wants to enhance the capacity of the health promotion directorate to develop research-based sustained malaria communication strategies in support of the various vector control interventions.
- TA TORs:
- 1. Recommendations for modification reinforcement for SBCC activities related LLINs, including the indicators currently being used and how SBCC data collection can be strengthened to allow for data-driven decision making to address barriers to uptake and use.
- 2. Improved approach for community mobilisation during and outside of mass campaigns in order to improve net use.
- 3. Provide direction around branding for NMCP, including possible links to Zero Malaria Starts with Me.
- 4. Recommendations for communication messages, channels and visibility materials.
- 5. Identify any future research priorities that should be considered for strengthening SBCC activities in the country.
- The responsibilities of the former NMCP have been divided among different departments and directorates of the Federal Ministry of Health. These include the Department of Health Promotion, the Directorate of Communicable and Non-communicable Disease and Integrated Vector Management (IVM).
- The available data on LLIN use and access is a bit stale, dating from a 2016 MIS, the research for which was conducted in 2015. A UCC was conducted in 2017, which makes the 2016 dated for SBCC purposes. A Tracking System at 3 months, 1 year, 2 year and 3 years after the 2017 UCC was planned for. IVM is compiling its findings from the Tracking system and will make them available as soon as possible.
- As the LLIN UCC is to begin in the five Darfur states in July 2019, there is a short fuse for updating
 messages for the campaign. Nonetheless, recommendations will be made for a quick turnaround of
 updated messages. UNICEF has committed to conducted rapid qualitative assessments in selected
 localities where use is deemed low as a way to determine existing barriers and ways to motivate the
 population to overcome them.
- Because of the short fuse on the start-up of the UCC, it will likely be best to incorporate the development of branding strategy into the development a Zero Malaria Starts with Me-style campaign, for which there appears to be considerable support.
- Reportedly, the incidence of malaria has increased in recent years, alarming those involved in malaria control. As a result, there is considerable support for reinforcing the SBCC efforts.
- Research trip planned to White Nile State for meetings with State Health officials, local NGOs, community leaders and locality health officials
- Debrief planned with FMOH officials to provide overview of findings and likely recommendations
