## Update on May 8th AMP conference call:

- Finished HH registration and waiting on final data
- The country does not set a cap at the start of the campaign. With no cap, we are just under 2.5 million nets short
- Next step is to figure out where the gaps are in terms of districts. Nearly all districts have over registered.
- Need to talk through quality control and fixing caps.
- New nets country: PNLP would prefer single strategy approach for whole country in terms of caps regardless of PBO study areas.
- Cannot fill the gap they have with the routine nets, so decisions need to be taken.
- First phase of distribution planned for mid-June and transport needs to start in next couple of weeks.

#### Update on May 8th AMP conference call:

- SBCC support from AMP is ongoing – weekly sitrep attached to the minutes of this week's call

- The National Malaria Control Program of Burundi is in the course of organizing a universal coverage LLIN distribution campaign, scheduled to take place in the first quarter of 2020.
- Priorities of the TA mission:
  - To support the NMCP in Burundi with the development of a communication plan for the campaign, including strategies for addressing challenges identified in the previous campaign
  - Support the NMCP in the finalization of key messages and channels of communication before, during and after the campaign, including visibility support
  - To support the NMCP in the finalization of communication tools (job aids for all phases of campaign for IPC, posters, flyers etc.) to be used during the campaign to promote behaviour change related to malaria
  - Support the NMCP in the development of a communication timeline for the LLIN campaign including timelines for all procedures for procurement and reproduction of media and materials
  - Support in the development of a draft advocacy plan and materials for validation
  - Support development of the communication parts of the campaign plan of action and in the training manual
- Campaign budget under discussion: GF needs this to be tied into a full malaria package including campaign, IRS and case management.
- Country asked to reduce the budget further
- Can't do the smartphones that they wanted to use. GF has agreed they can pilot with IRS for use of smartphones.

#### Update on May 8th AMP conference call:

- VectorLink had call with the country team and PMI team in country: for the far north, the DawaPlus nets should be going shortly. Expectation is that all batches of Dawa and Olyset nets should be coming in July into the country around the same time.
- There are no longer plans to do a two-phase campaign at this time, but only one full distribution under one phase. NMCP don't want to integrate activities. There will be sequential activities including the HH registration.

- Looked like there were so many activities that were going to collide that it would be a HR nightmare to integrate.
- Finished review of contingency plan for north west and made adaptations for security. South west still to be done
- AMP to travel next week to provide support for phase 1 distribution and phase 2 HH reg that will be rolling out simultaneously next month.

# Update on May 8th AMP conference call:

- AMP mission ongoing weekly sitrep attached to the minutes of this week's call
- TA for 2019 targeting regions 1, 2 and 3 in 2 phases
- With support from AMP consultant, developed macro plan with the budget, and chronogram of all activities for 2019 finalised
- Planned that camping covers 39 sub prefectures, but based on last 2-year campaigns, realised that it will be hard to cover all districts. Idea is now to cover only 22 districts out of 39 and see if we can cover the rest next year
- Challenge is with the selection of implementing partners: local NGOs used to implement activities on ground: with the experience from last campaign, it was noted that local NGOs are very weak and not present in the regions where campaign is to be implemented. WV had to relaunch the recruitment process for new partners for implementation in the 22 districts

#### Update on May 8th AMP conference call:

- GF campaigns update:
- Finished microplanning for all 6 states.
- Ongoing activities in Delta and Yobe. State level training completed and now doing LGA cascade training. Both COEs: could not have AMP in country missions for security reasons but remote support to be provided.
- Strategy developed for high risk LGAs for partially and complex and inaccessible areas. Number pf HHs covered per day reduced for hard to access areas. Where there is no access, no fixed point distribution.

- Insecurity is very spontaneous in these areas, fine tuning how this will be done and what is the best approach in terms of mobile distribution.
- Taraba state starts distribution on 8<sup>th</sup> June
