- Entretien avec l'équipe du Mali et préparation de la mission à l'intérieur du pays avec l'équipe du PNLN
- Voyage dans les régions de la Boucle du Mouhoun et du Sud-Ouest pour les entrevues avec les différentes parties prenantes des niveaux décentralisés (niveau région et niveau district), l'observation du processus de la distribution (sites de distribution et ménages), la collecte des données pour l'évaluation des processus de la campagne

Situation :

- Les **microplans** sont compilés et les synthèses disponibles et partagées
 - Synthèse des microplans transport pour PAM ;
 - Synthèse des microplans districts pour les ABC,
 - Synthèse des quantifications des outils-districts,
 - Synthèse générale des microplans
- La **synthèse du budget** des activités est finalisée et le budget a été revu en réunion de travail 03 jours durant entre PNLP, PNUD et CARITAS ;
- La **formation des superviseurs nationaux** a été réalisée du 02 au 04 octobre et ceux-ci- ont facilité, la formation des superviseurs provinciaux et de district du 08 au 11 octobre ;
- Une réunion a été tenue entre PNLP, ISTEEBU et APP, une esquisse de chronogramme a été élaborée pour la réalisation **du monitoring indépendant** par ISTEEBU en parfait alignement avec le démarrage du dénombrement, un projet de protocole et de budget devront être soumis au PNUD par ISTEEBU et un contrat signé au plus tard le 15 octobre ;
- La **formation des agents de saisie** : initialement prévue lors de la formation des dénombreurs et superviseurs de proximité, qui avait été reprogrammée pour une session spéciale à J2 du dénombrement sur les données réelles (les SIS des CDS étant regroupés chez les SIS du District pour une saisie en temps réel comme méthode de formation) sera finalement organisée avec la formation des dénombreurs et superviseurs de proximité pour éviter un dépassement budgétaire ;
- Un **nouveau chronogramme** a été partagé entre parties prenantes pour une seule phase avec dénombrement prévu du 08 au 19 novembre et distribution du 09 au 13 décembre 2019 ; le monitoring est prévu du 11 au 15 novembre 2019 ; (à valider par le comité de pilotage)
- Le **plan logistique** est stabilisé : les outils logistiques sont révisés ;
- Une situation est disponible sur l'état de la **production des outils de mise en œuvre** avec une infime partie produite le reste étant planifié pour une livraison entre le 15 et le 30 octobre (le dénombrement est prévu à partir du 08 novembre). Il y a cependant **toujours incertitudes sur la production et**

livraison des coupons, supports de communication et outils de gestion de la campagne au niveau des provinces ;

- Une **révision de la quantité des outils** à produire a été faite sur base des microplans. Les imprimeurs n'ayant pas encore commencé l'impression des documents, la commande pour tirage et quelques modèles ont pu être modifiés. Cette nouvelle information devra immédiatement parvenir à l'imprimeur ;
- Un jour supplémentaire pour une **formation sur la gestion logistique** des 1,830 responsables de sites distribution des MILDA a été accepté par le FM ;
- La **formation des formateurs nationaux sur la gestion logistique** a été réalisée le lundi 14 octobre, orientée aux sujets concernant la traçabilité entre la réception au site de distribution, et la logistique inverse de retour des surplus vers les districts sanitaires. Un avis de non objection a été rendu par le FM pour cette activité qui n'était pas dans le budget déjà autorisé ;
- Les **paquets d'outils et de supports pour les formations** des acteurs (formateurs communaux et agents dénombreurs, superviseurs de proximité et agents de saisie) sont finalisés ;
- Les **exercices de la formation logistique** du 14 octobre, modifiés selon les commentaires et suggestions des participants sont intégrés au Plan d'action logistique finalisé qui sera circulé aux partenaires et formateurs ;
- **L'évaluation des risques** a été partagée avec les partenaires en session du comité de pilotage (COPIL) le 15 octobre en présence du Ministre de la Santé lui-même,
- Le **budget est révisé** et consolidé avec les microplans tout en restant dans l'enveloppe initiale ;
- Un draft de **plan de mitigation** des risques est disponible (risques liés au retard de livraison des MILDA et outils, au système de paiement, à l'insuffisance des quantités de MILDA après dénombrement, à la confusion entre MILDA de différents types, à la confusion entre les stocks de routine et reliquats de la campagne, aux dépenses inéligibles...) ;
- Le **plan d'action est mis à jour**,
- Le **système de paiement** a été abordé en session du COPIL avec le Ministre qui a suggéré que le système utilisé pour la campagne méningite et validé par le LFA serait reconduit. Les blocages ont été identifiés et le Ministre a donné des instructions fermes pour la mise en place du système.

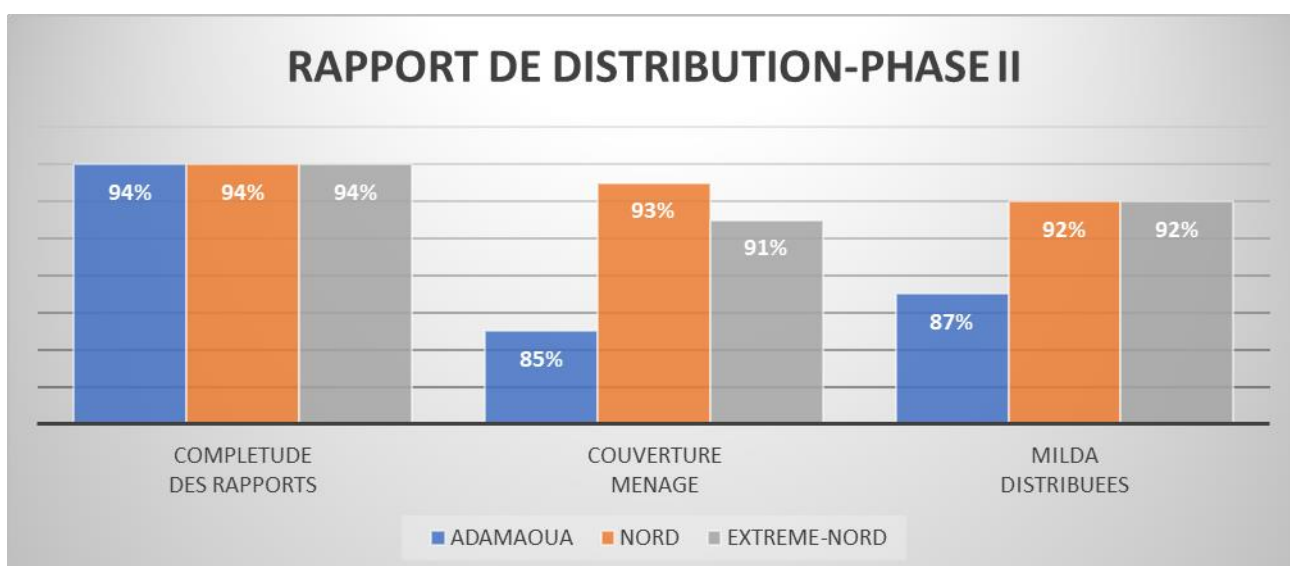
Résultat de la distribution dans l'Extrême-Nord

- La distribution des MILDA aux ménages dénombrés dans le cadre de la Campagne de distribution des MILDA avait été prévu, dans la région de l'Extrême-Nord, durant la période allant du 19-23 septembre 2019. Après une distribution des MILDA de 5 jours, il a été recommandé de prolonger la période de distribution de 2 jours pour un ratissage.
- Il est à souligner que cette première phase n'a concerné que 14 districts sur les 30 de la région.
- Les résultats provisoires à J5 se présentent de la manière suivante :

- 94% des rapports de distribution des aires sont disponibles à ce jour, avec :
 - 91% de couverture des ménages attendus.
 - 92% des MILDA distribuées.
- Durant les deux jours de ratissage, il a été recommandé de se rassurer que les équipes de distribution informent les ménages restants par téléphone et si possible avec l'appui du crieur.

Résultat de la distribution dans le Nord et Adamaoua

- Etant donné que certaines aires de santé des régions d'Adamaoua et du Nord ont démarré leur distribution en retard due à un retard d'acheminement des MILDA, dès le démarrage de ces aires de santé les résultats se présentent de la manière suivante en ce jour :
 - La région de l'Adamaoua :
 - 94% des rapports de distribution des aires sont disponibles à ce jour, avec :
 - 85% de couverture des ménages attendus.
 - 87% des MILDA distribuées.
 - La région du Nord :
 - 94% des rapports de distribution des aires sont disponibles à ce jour, avec :
 - 93% de couverture des ménages attendus.
 - 92% des MILDA distribuées.

Difficultés rencontrées :

- Gap des MILDA par rapport aux besoins du dénombrement des ménages.
- Rupture de stock au niveau de plusieurs sites de distribution.
- Problèmes de remplissage des outils au niveau des sites de distribution.
- Faiblesse de communication au niveau du site de distribution.
- Problème de supervision avec absence régulière des superviseurs surtout des aires de santé
- Non-paiement des crieurs pour la phase de dénombrement des ménages.
- Le retard de paiement de la CPS (2 séries) démoralise les superviseurs.

Update on November 16th AMP conference call:

Meetings:

The authorities of the DOMC had to convene a meeting summoning the IFRC/PRCS country team to update the TWG members on the inability to secure NOC for further accessibility of other complex operating environments in the Tribal districts that could not be accessed as reported from the previous week.

The concern around this was the promised made earlier that the NOC was almost at the stage of being granted. The meeting was intimated by the IFRC/PRCS team that the final evaluation of the process was reached and the authorities in-charge of granting the NOC were deemed to have been satisfied

with the condition precedent upon which the request will be granted. However, the following key decisions were arrived at;

IFRC/PRCS will continue to follow up on the process until the request is finally granted

IFRC/PRCS should explore possible option of entering a consensus with the health authorities of FATA and KP to implement the process through the existing IVM structures through a collaborative effort that will de-emphasize the campaign as being perceived as a PRCS program.

IFRC/PRCS has requested a no cost extension to enable them follow through the NOC request and further build on the lessons learned in the just concluded distribution in the initial 14 districts to improve the process in the phase II

Activities accomplished:

The distribution process was implemented in the 14 districts despite some challenges which included the following;

There was Nationwide internet/network distributions due to a political protest against the authorities by other political coalition. This has affected the use of RedRose application in many areas.

Some districts in other remote areas were not able to take off on the proposed distribution dates either due to some logistics related issues or volunteers not being timely present at the DPs. Issues around changing of DP locations at the last minutes were witnessed, however the monitoring team have advised against these highlighting the potential consequences

Redemption rates in some districts were low and the monitoring team had to work with key implementing partners to improve further on these. Based on this the campaign had to extend further for additional 2 days as a mop up strategy.

The TA mission also worked with the IFRC/PRCS/DOMC/IHN to finalize the country's Logistics Report and Reconciliation Tool (LRRT)

A framework was also developed for LLLIN accountability and reverse logistics in a transparent manner that will guard against potential risk of LLIN loss.

Update on November 16th AMP conference call:

Meetings / working sessions:

- Initial meetings were held with NMCD personnel to determine an action plan for the mission. Challenges faced in 2017/2018 were discussed, as well as expectations for the upcoming mission.
