Technical

Coordination Meetings

As part of improving LLIN coordination and planning, the weekly coordination meeting was held on February, 06 with the participation of all key NMCP focal persons, USAID PMI officers and PSI

National coordination committee meeting was held on February, 10, Chaired by deputy national coordinator of NMCP with all key NMCP focal persons, MINSA representative (Angola Ministry of Health), officers representing OMS, UNICEF, USAID/PMI, PMI/CDC, PSI, Malaria Forum and Vector Works.

- Updates from each focal person were presented
- VW consultant provided feedback on micro planning workshop based on the draft report already made available to NMCP and all relevant partners
- PMI has provided official information about PSI being selected has campaign implementing agent
- NMCP provided feedback on the committees and subcommittees and support letter to be signed by the Ministry of health and to be sent to governors at the provinces
- NMCP provided a finally decision on the 06 provinces to be prioritized (Zaire, Cunaza Norte, Malanje, Moxico, Cuando Cubango and Cunene).
- Number of provinces to be covered on first wave distribution will depend on number of LLINs available

Logistics

New delivery schedule of LLINs provided by PMI
According to PSM 1.4M LLINs will arrive in Luanda on the first week of April
Remaining 3.4M will arrive by late May
According to NMCP GF will provide 0.8M LLINs
Total number of LLINs available for the first wave distribution is 2.2M
Quantification of log tracking tools and other campaign material was done and shared with NMCP
PSM, PSI, UNITEL, UNICEF, CECOMA, NEOFARMA will compose logistics subcommittee and NMCP has lead.

- Update of draft logistics plan of action based on the new delivery schedule
- PSI to share revised micro planning timelines at municipal level and strategic plan for the whole campaign
- Select the provinces for first wave distribution of 2.2 M LLINs in May/Jun
- Procurement of campaign materials
- Agree on how GF LLINs nets stored at NEOFARMA will be sent to the Municipalities
