Country updates provided on January 20th AMP call:

CAR	
Country summary	 Security situation has degraded significantly in the country over the last weeks AMP will have a catch-up call with NMCP CAR next week.



Chad	
Country summary	 Chad has completed 5 phases of campaign activities. Country is currently working on 6th phase distribution. Current plan is to start Phase 6 distribution by the end of February. Government of Chad to fund ITNs to complete ITN distribution.

Cote D'Ivoire	
Country summary	 Vector Link team working to distribute PBO nets which arrive in February HH registration ongoing AMP has provided feedback on Plan of Action

DRC	
Country summary	 ITN distribution ongoing in three provinces Tanga, Congo Central, Haut-Lomami AMF partner SANRU will use mobile devises for data collection GF DRC CT is currently making small changes within team AMF and Global Fund will review planned provincial level distributions in 2022 – 2023. This planning will align with Global Fund grant cycle.

Country summary	 Next distribution of 7.8 million ITNs funded by GF and PMI PMI funded ITNs to arrive in February Remaining ITNs will arrive in April Central level ToT and micro planning to take place next week Workshops will covered lessons learned

Country summary	 Plan to start trainings in three regions in Ghana in the coming months Plan to train during the month of Jan. and start ITN distribution in March

Country summary	 Country is having challenges in aligning macro documents. Main issue is the concern on SBC component. Waiting for Communication and Log PoAs Significant coordination challenges

Madagascar	
Country summary	 AMP is providing two waves of support 1) Development of a Road Map 2) Draft PoA Some changes in personal at NMCP have caused delay in document finalization

Malawi	
Country summary	 The 2021 mass ITNs distribution campaign will target 25 districts in Malawi. Excluded from the campaign are Mangochi, Balaka, Nkhotakota and Nkhatabay districts that will benefit from the indoor residual spraying program. The total quantity of ITNs to be procured for distributed in the 25 targeted districts as (estimated using projected census data) is 9,258,645. There is no buffer that has been procured since the last census is less than 10 years old. The 2021 campaign will employ a two-phased fixed site distribution strategy with a door-to-door household registration to determine the numbers of households in every community and the number of people in each of those households followed by fixed site
Law COtt and Late	 distribution almost 3 months later. They will not use vouchers and will instead use their registration books to identify recipients at the distribution points.
Jan. 20th update	 The AMP TA team has conducted two phone calls with the Malawi NMCP and Deputy Director of Preventive Services and discussed the draft implementation strategy which includes technical and M&E, logistics and SBC. The AMP TA team is currently participating in 2- day virtual National Taskforce Meeting on zoom that is aimed at reviewing and finalizing the implementation strategy. The country did not plan for C19 in their GF grant therefore there is a potential funding gap for C19-related IPC materials and PPE.
	 The implementation strategy did not mention C19 so there is work to do to update it and insert risk mitigation adaptations. In their previous campaigns they had a 4 - 5 months gap between registration and distribution. This makes the campaign unsuitable for the use of vouchers
