

- The 2021 mass ITNs distribution campaign will target 25 districts in Malawi. Excluded from the campaign are Mangochi, Balaka, Nkhotakota and Nkhatabay districts that will benefit from the indoor residual spraying program. The total quantity of ITNs to be procured for distributed in the 25 targeted districts as (estimated using projected census data) is 9,258,645. There is no buffer that has been procured since the last census is less than 10 years old.
- The 2021 campaign will employ a two-phased fixed site distribution strategy with a door-to-door household registration to determine the numbers of households in every community and the number of people in each of those households followed by fixed site distribution almost 3 months later.
- They will not use vouchers and will instead use their registration books to identify recipients at the distribution points.

# April 21st update

- Malawi national task force team members are currently conducting a campaign national briefing at regional level, involving district government and health from all the districts targeted for the 2021 ITN campaign.
- The teams will be presenting the campaign implementation guides as well as the road map and they will hand over to the district health officers, the list of information to be collected ahead of microplanning.
- The draft strategy for the distribution at Chauma and Lupachi communities in Nkhotakota district is completed and is to be shared and discussed with the Malawi team
- The Program Implementation unit (PIU) has already sent out the call for tender for the selection of the logistics service provider for the campaign
- Review of the logistics tracking tools is in progress
- Mapping of existing incinerators for waste management at district level as well as the capacity in terms of volume and temperature is in progress.
- There was an SBC microplanning orientation for the SBC subcommittee to bring the team up to speed on the upcoming microplanning process.
- Reviewing of the SBC microplanning template is ongoing.
