System and Data Security

Privacy, confidentiality and the security of data and communications is always our number one priority in the solution's design.

- Role-based user management with fine-grained rights control on the system and the application.
- Unique username/password pairs with options for additional two factor authentication.
- All communication between users, applications, APIs, and the platform are encrypted by industry-standard SSL.
- The platform and device database has an encrypted data-at-rest configuration (AES256).
- All actions have a full audit trail available for traceability.
- RedRose is GDPR compliant*, SOC1 compliant, and conducts regular security testing

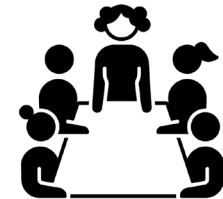
